As you near your 70s, you need to be prepared for when required minimum distributions from your retirement accounts kick in. "The RMD is something the government plans for us — on their schedule, not yours," said Maggi Keating, CFP®, a financial planner at FBBCapital Partners and the spouse of a retired Marine Corps colonel.

Many savers have amassed hefty pretax retirement account balances, and RMDs are calculated off those balances.

"These distributions are becoming more sizable, and becoming more of a tax issue," said Keating.

RMDs could spike you into a higher tax bracket as they add to your ordinary taxable income, which may already include military retirement pay and Social Security, among other sources of retirement income. Plus, if you fail to take out the right amount, you can incur a penalty from the IRS.

Understanding the rules for RMDs not only helps you avoid trouble with the IRS, but that knowledge can also present strategic opportunities to make the most of your nest egg, and in some cases, even keep your tax tab to Uncle Sam in check.

The First RMD

The federal government previously raised the starting age for RMDs to age 72 from age 70½, and the new SECURE Act 2.0 law further raises the age original owners of retirement accounts must begin taking RMDs.

No matter the starting age, for your first RMD only, you get an option to delay taking it. You can take the first RMD by the end of the year in which you reach RMD age. Or you can wait to take it until April 1 of the year following that birthday (that April 1st is known as your required beginning date, or RBD).

Lunch was served: Salmon, Rice, Green beans, and Chocolate Cake with Ice Cream.

MAJ Gonzalez asked Maj Curt Voelbel to pin the Chapters 5 Star of Excellence medallion on our Chapter's ribbon on our flag.

MAJ Gonzalez asked Maj Curt Voelbel that the 50/50 drawings be done at this time. Followed by the members' free lunch drawing.

LtCol Twila Davis won the free lunch for the 1 March 2023 meeting/luncheon.

MAJ Gonzalez introduced the guest speaker: Bob Watson is the Director of Veterans Services for Volusia County Florida. As Director Bob trains, coordinates and leads a team providing assistance to veterans in determining and obtaining potential VA benefits. Bob started as an accredited Veterans Service officer in 1993. Bob grew up in Pinson Alabama and lived there until he joined the United States Marine Corps in 1972. He retired from the Marine Corps in 1992 as a Master Gunnery Sgt. Upon his retirement from the Marine Corps, he became a staunch advocate for veterans and to this day it remains his passion.

Bob is married to Gwen Watson and resides in Deland, FL.

Mr. Watson stated Florida is the most Veteran Friendly state and Volusia County is ranked first in providing support to veterans. Florida is ranked #2 nationwide, with Texas ranked as #1 and California is #3. Mr. Watson stated Volusia County has approximately 72,000 veterans.

Mr. Watson stated the most important take aways for today are:

1. If someone offers to help you file a VA claim and charges you a fee -RUN away. All veterans need to visit one of the Volusia County Veterans Service Officers. Offices are located in DeLand, Orange City, Daytona, and New Smyrna Beach.

2. Mr. Watson stated if there are any veterans that would like to volunteer to help other veterans, Volusia County has a Veteran's Court to oversee cases of veterans. If you would like to be a mentor, please let him know and he will connect you with the program manager.

Mr. Watson then introduced Scott Olson, Veterans Services Officer to explain some of the VA benefits.

Mr. Olson explained there are two sides to the Veterans Administration: VHA Veterans Health Administration and VBA- Veterans Benefit Administration. He recommends all veterans register in the VA Health system. Especially with the passing of the PACT Act which opened up benefits to Gulf War Veterans. Mr. Olson explained there are several different categories of covered medical conditions: Direct---while on active duty you were running and fell and injured your left knee; Secondary---you develop a right knee condition secondary to the left knee injury, Aggravation---the is an aggravation of a pre-existing condition, and Presumptive---conditions that are assumed to be secondary to military service/exposures---like agent orange.

Mr. Olson stated surviving spouses may qualify for benefits such as VA Pension-the criteria is same for the veteran and is need based; and VA Dependency and Indemnity Compensation (DIC) - surviving spouse, child or parent of a service member who died in the line of duty, or from a service-connected injury or illness disability. Please refer any spouse or family member to the Veterans Services Officer for assistance.

MAJ Gonzalez thanked Mr. Watson and Mr. Olson for speaking to the Chapter today and presented a certificate of appreciation to Mr. Watson.

But then “the problem is you have to take two in one year,” said former Capt. Keola Elobt, USA, MBA, AIF, a West Point graduate who is now the group head of MAI Retirement at MAI Capital Management. If you delay your first RMD, you also have to take your second distribution in the same year. The second and all subsequent RMDs must be taken by Dec. 31 of each year.

Consider how doubling up your RMDs might affect your tax bill. If doubling pushes you into a higher tax bracket, you might want to forgo delaying and take the first RMD in the year you reach RMD age.

Guest Speaker's Bio -

Jake Johansson began his career as an enlisted sailor in the United States Navy. He attended night school at Troy University and received his commission as an officer in 1989. He was winged as a Naval Flight Officer in 1991.

In his 35-and-a-half-year career he held numerous leadership positions at the line and staff level. He flew combat missions in support of multiple operations in Iraq and Afghanistan. He was the commanding officer of Patrol Squadron FOUR and they safely flew over 5000 hours of combat missions over Iraq without incident. His staff tours were with the Chief of Naval Operations in the Pentagon, and later in his career with the Commander, Naval Air Forces Pacific. He was also personally selected by Vice President Richard B. Cheney as his Naval Aide for three years carrying the "football." He also was selected to command a Naval Base (Naval Support Activity in Norfolk, Virginia) and was responsible for 5 local naval bases of national importance. During these tours he was a guiding force in base operations, infrastructure development, military-civil collaboration, homeland security, ethics training and investigations, and leadership training. He has been awarded an Air Medal, Bronze Star, Legion of Merit and Defense Superior Service medal for actions in defense of our nation.

He has a Master's degree (honors) in Public Administration from Old Dominion University.

Prior to his election as your Volusia County At Large representative he was the City Manager of Port Orange, FL from August 2015 to December 2020.

He has served on multiple boards and committees in his military and civilian career.

He and his wife currently own and operate Core Concepts Leadership consulting specializing in keynote speaking, executive coaching and organization leadership training. They are facilitators of the Port Orange, South Daytona, Daytona Beach Shores Youth Civic Leadership Training Experience and the Southeast Volusia Leadership program.

He was elected to the Volusia County Council and started serving in January 2023. He has a four-year term.

The Chaplain's Corner -



I don't know if it is a curse that only we as Americans face, but too many people live in the future all the time. We are always thinking about what is next instead of enjoying the time we have right now. I've noticed this in my parish, but even once at EPCOT for the Candlelight Processional I watched people leaving before the music was over. It is sad really. We know that life can only be lived one day at a time, and yet we so often forget that and miss out on the opportunity of the moment.

It seems that even Jesus needed to find ways to be present at each moment because the crowds could be overwhelming. After a day of healing the sick Jesus slipped out of town to find quiet in the wilderness. Peter seeks out Jesus and tells him that everyone needs him and he should come back. Jesus realizes His mission would not allow him to escape. Instead, the solace He found with the Father gave Him the ability to minister to all those who needed him.

Fr. Solanus Casey, a Capuchin priest, spent his life in service to God's people. At the friary door as porter he met thousands of people from every age and walk of life seeking help or wanting a tour or needing confession. He earned recognition as "The Doorkeeper." He was always ready to listen to anyone at any time, day or night. He once said, "Man's greatest holiness lies in being faithful to the present moment." Some say when they met Fr. Solanus they met a living saint. I think he was onto

something. Being present with people, with God in prayer, and with nature can lead us to a greater holiness. (The Catholic Church has declared Fr. Solanus to be Blessed, the step before being declared a saint.)

I've also discovered an insight about being present in the moment. Things that we fear most often do not occur, and things that are good happen more often than we imagine or plan for. Yet, we spend a lot of energy worrying about future possibilities and less time savoring current gifts and blessings. When we are able to pause and realize how often someone has crossed our path and smiled at us, let us go ahead in line at the grocery store, went out of their way to help us with a problem, or just listened when we needed an ear, we would discover that God is present so often, but we miss it.

I try each day to see something beautiful. I pause to notice the sunrise and sunset, the Sandhill Cranes, and the children at play next door. I try to see good in each person and greet them when I am taking a walk. I know I am not successful at it all of the time, but I try to make a conscious effort to be in the now. I pray that you will find the peace that only God can give and that He helps you to slow down so as not to miss the moment.
