A new Bill to save spouse access to medical leave benefits. A bipartisan Bill to better support military families will help ensure military spouses are eligible for key protections that have positively impacted the lives of millions of workers without an undue burden on employers.

The Ensuring Access to FMLA leave for Military Spouses Act was introduced July 10 by Reps. Marilyn Strickland (D-Wash) and Don Bacon (R-Neb) , would reduce the qualifying time for which a military spouse must be employed prior to taking leave under the Family and Medical Leave Act (FMLA) from 12 months to 90 days.

The FMLA signed into law in 1993 guarantees eligible employees up to 12 weeks of unpaid, job-protected leave for specific family and medical reasons.

To be eligible for FMLA leave, employees must have worked for their employer for at least 12 months and worked at least 1,250 hours over the past 12 months.

Today's speakers: LTC Michael Magee, LtCol Chris Hoffman, and MAJ Raul Gonzalez presented a "ROUND TABLE" DISCUSSION:

Discussion highlights:

As we all know, it is the military service member who is the ONLY U.S. government employee who takes an oath upon enlistment or commission, and every time thereafter upon promotion to "... SOLEMNLY SWEAR TO SUPPORT AND .DEFEND THE CONSTITUTION AGAINST ALL ENEMIES FOREIGN AND DOMESTIC...".

All service members who attain the rank of senior non-commissioned officer (NCO), warrant officer (CWOs) & officer and retire with said rank bear this burden until they die. Even the POTUS' oath to office does NOT include the above language.

The United States Constitution was drafted at the Constitutional Convention in the summer of 1787 and signed on September 17, 1787, by delegates from 12 states to establish a new, stronger federal government. It replaced the Articles of Confederation and created a federal democratic republic with three branches of government. James Madison is often called the "Father of the Constitution". Delegates made numerous compromises to resolve contentious issues, including those related to representation, slavery and the slave trade. It is the world's longest surviving written charter of government and serves as the supreme law of the land, establishing a federal democratic republic.

The United States Bill of Rights comprises the first ten amendments to the U.S. Constitution. It was proposed following the bitter 1787-88 debate over the ratification of the Constitution and written to address the objections raised by Anti-Federalists. The amendments add to the Constitution guarantees of personal freedoms, such as freedom of speech, the right to publish, practice religion, possess firearms, to assemble and other natural legal rights. They limit governments' power. These amendments, crafted by James Madison, were approved by Congress on September 25, 1789 and submitted to the states for ratification. PMESII-PT stands for Political, Military, Economic, Social, Information and Infrastructure-Physical Environmental and (Continued on page 5)

What a month we have had!

We know this world is violent. Those of us who have served don't need to be reminded of that fact. On 9/11/25 we were remembering those who lost their lives in the devastation of that terrible day 25 years ago. There were documentaries and other programs that recalled these events in the last month. Then, there was the shooting in Minnesota that seemed so random, and yet we don't know, and maybe will never know why a Catholic school with children was targeted.

Most recently, there was the assassination of Charlie Kirk that jolted us. America is supposed to be the place where all ideas can be shared and debated. Yet, on that day, someone thought that the opinions of a young man who believed in God, in the sanctity of marriage and family life, and in living a moral life was somehow objectionable. He had to be killed, according to his assassin.

I don't pretend to know why these things happened. I do know that evil takes hold when we don't have a strong moral code to live by. Perhaps our job is to show the world a different way to live and to express our opinions. Maybe we can show those who think violence is the only answer that people can agree to disagree and it doesn't have to lead to violence.

I pray that those who have experienced the loss of a loved one in violence of any kind might find peace and consolation. I pray too for those family members who have had a son or daughter commit a crime and are now in prison. They wonder what went wrong and what can be done, if anything to make the situation better.

May we work for solutions that offer an alternative to the violence we have witnessed

and provide a pathway to a better world where all can live in peace.

Guest Speaker's Bio -

Sara R. Owens.

Sara was raised in Fort McCoy, Florida, right outside of Ocala. After graduating as an honor student in 1995 from North Marion High School, she joined the United States Marine Corps. Sara arrived at Recruit Training Depot Parris Island, South Carolina on October 3, 1995 and earned her Eagle, Globe, and Anchor on December 29th, 1995 graduating in Platoon 4001.

After bootcamp, Sara attended Aircraft Maintenance Administration School in Meridian, Mississippi before receiving orders to her first duty station in Okinawa, Japan. In Okinawa, Sara was attached to HMM-265, a Helicopter Squadron, and participated in a deployment to Pohang, Korea for five weeks.

Upon completion of one-year in Okinawa, Sara received orders to Pensacola, Florida. In Pensacola, she was attached to the Aviation School as an administrator.

In 1999, Sara reenlisted for another 4 years and received orders to Cherry Point, North Carolina, attached to VMAT-203, a Harrier training squadron, which only deployed within the United States, to Yuma, Arizona. By the end of her second enlistment, Sara had given birth to two daughters and the Marine Corps was ready to send her to a deploying squadron, deploying to the Middle East. Although she loved the Corps and loved being a Marine, she couldn't leave her two daughters, so she decided to get out of the Marine Corps. After eight years, Sara was honorably discharged October 14th, 2003, as a Sergeant, E-5.

For 18 years, Sara focused on raising her daughters and put most of her military life behind her and out of mind. During this time she also, completed a Master of Science in Accountancy with the University of Phoenix. March 12th, 2021, Sara found her way back to serving her country and joined the Orlando Devil Dogs Young Marines as the Executive Officer. March 1st, 2022, she chartered Volusia Young Marines, closer to her home in Edgewater, Florida. Volusia Young Marines earned Unit of the Year for the Florida Regiment a year later, in 2023. The Regiment consists of 16 Young Marine Units throughout the State of Florida. In 2025, Sara earned Adult Volunteer of the Year for Division 2. Division 2 consists of all the units

throughout the States of Florida, Georgia, Alabama, Tennessee, North Carolina, and South Carolina. April 2025, Sara was appointed North Regiment Support Officer and assigned 9 Young Marines units, to include Volusia Young Marines.

Sara is also an active member in the Marine Corps League, she joined the Captain "Tiger" Mayberry Detachment 658 on December 20th, 2021 and is currently the Detachment Adjutant (Administrator).

A year later, she joined the Military Order of the Devil Dogs Sgt G.B. Reasner Jr. Pound 124 and is currently the Pound Dog Robber (Accountant).

Sara is married to David Owen who works alongside her and holds officer positions as well in all the before mentioned organizations.

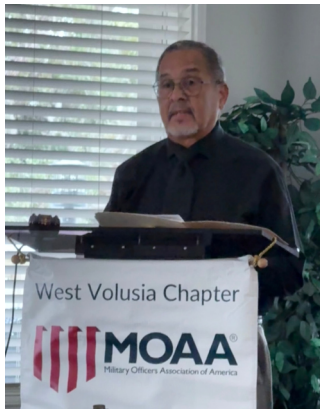
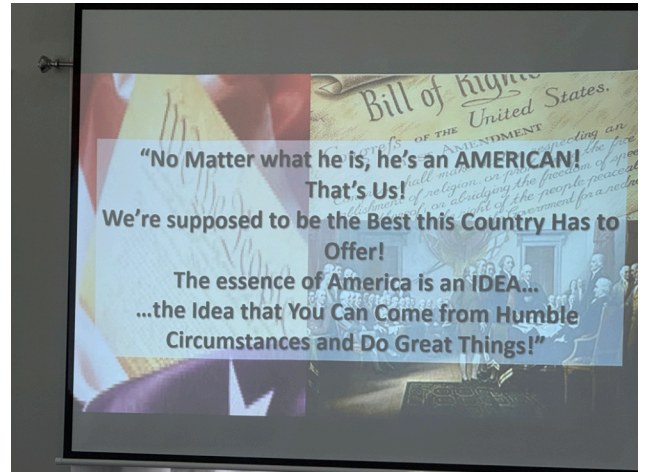
Habitat by Veterans -

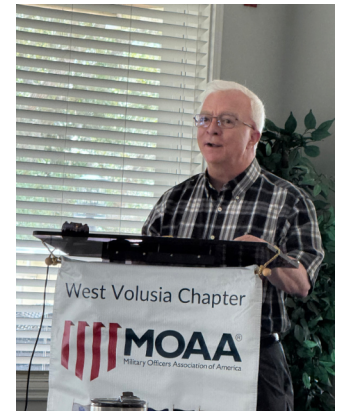
Photos from September luncheon -
